# REPORT.

---

In Town Meeting, March 4th, 1856, the following Resolution or motion was adopted, to wit:

*Resolved*, That the present and all future boards of Selectmen, Auditors and Overseers of the Poor, be directed to prepare their several Annual Reports in *minute detail*, at least ten days before the Annual March Meeting, and that the Selectmen cause 800 copies of the same to be printed for the use of the town, at least five days before said meeting, 300 copies to be left at the Court House, and 200 copies \_\_\_\_\_ place in the West Parish.

In compliance with the above resolution, the Selectmen make the following Report: .

An appropriation of \$600 was made at the last March Meeting, to enlarge the dwelling-house, on the Town Farm, under the direction of the Selectmen and Overseer of Poor, which has been done by Isaac Gibson's building an additional story to said house, in a manner that we think will be satisfactory to the Town, at a cost of \$560.00.

It will be recollected that there remained due to the West Parish, towards building their Town Hall, the sum of \$500.00, which has been paid.

There has also been paid Sheldon, Morgan, Slason & Co., for building a road west of their mill, \$460.50,—which road was contracted for some 3 years ago.

A new road has been built below Erastus Wells', and the road straightened, at an expense of near \$500.00.

The bridge at Sutherland Falls, and the Ripley bridge, have been repaired the past season, costing some \$300.00.

The Selectmen have of late laid out two roads in the village,—one from the depot east to Main street,—and one from West to Washington street, on which some appeals have been taken.

A Court's Commissioners have recently laid a road from the quarries in West Rutland, north to E. C. Chatterton's, which Report will go before the County Court, in March next, for approval or rejection.

The accounts of the Overseer of the Town Poor have not been submitted to the Auditors for examination.

It will perhaps be expected by some that the Auditors would present a full statement of the outstanding liabilities of the Town, and its probable expenses for the coming year, as well as of the funds which may be required to meet them. To do this in a satisfactory manner it would be necessary, among other things, to know what orders had been drawn upon the Town by the Selectmen, Overseer of the Poor, &c., and to ascertain how many of them had been paid in and how many are still outstanding. It has not been practicable for the Auditors to accomplish this, as they have not had access to any lists of orders drawn, &c. Other officers of the Town are also much better able, from their acquaintance with its affairs, to estimate what liabilities the Town may come under during the ensuing year.
